SUBJECT: OSAA Football Ad Hoc Advisory Committee Update

The Football Ad Hoc Committee conducted its eleventh public meeting on November 18, 2019 at the OSAA Office in Wilsonville. Committee recommendations will be forwarded to the OSAA Executive Board for review and potential adoption on February 10, 2020.

OSAA staff provided a summary of 11 pieces of correspondence received after the last meeting. The Committee received testimony or comments from 22 individuals. The group then convened into a work session to discuss those items outlined on the posted agenda.

At this point the group is currently supporting the following recommendations:

- Using criteria to identify teams eligible to play down a classification for a two-year period. A complete list of qualifying schools to play down for the 2020 and 2021 seasons is included within this update and those schools will have until December 2, 2019 to notify the Committee of their intent.
 - Any team with a two-year in-classification winning percentage of 22% or lower will have the option to move down a classification level.
- Using criteria to identify teams that would be required to move back to their originating classification level after playing down for a two-year period.
 - Any team with a two-year in-classification winning percentage of 66.67% or higher is automatically moved to originating classification after the two-year period.
 - Any team that wins an OSAA Football Championship game, regardless of round, is automatically moved to originating classification after the two-year period.
 - The Committee is also discussing adding an additional criterion that would allow review of any team under the 66.67% percentage outlined above but has demonstrated through a combination of winning percentage, league finish, participation numbers, or state championship qualification that it may need to be moved back up.
- Eliminating the following original criteria moving forward as the two-year in-classification winning percentage of 22% or lower captures 99% of the teams.
 - \circ $\;$ Any team with a four-year in-classification winning percentage of 22% or lower $\;$
 - \circ $\;$ Has played 12 or fewer in-classification games during the last four years.
- Continue piloting 6-player Football for the 2020 and 2021 seasons with the following modifications:
 - Adjusting the enrollment limit to better represent 6-player school populations. This is still under discussion and will be finalized at the next meeting of the Committee.
 - Extending the 6-player cutoff date two weeks to allow for an unofficial semifinal and championship game.

- During the pilot, no OSAA State Championship will be awarded at the 6-player level.
- Modify the current structure to include 9-player Football at the 2A Classification level starting with the 2020 season.
 - 2A schools choosing to continue to play 11-player will have the option to participate at the 3A level in Football and would not be required to move other sports/activities up to the 3A.
 - Under this recommendation, 8 player teams in the enrollment zone of 89-120 would play 9 man thus eliminating the enrollment zone for 8 player football. 1A teams choosing to play up to 9 man would have the option to participate in football only and would not be required to move in other sports.
 - It is recommended that 2A schools currently playing down to the 1A level would be returned to the 2A classification to participate in the 9-player game.
- Reorganize schools participating at the 4A Classification level into either 4 or 5 Special Districts. Several proposed alignments are included within this update.

Summary of teams who have played down during the last two-year period – any school with a two-year in-classification winning % greater than or equal to 66.67% or has won an OSAA Football Championship game, regardless of round, is automatically moved back to their originating classification level.
