Subject: 2014 Baseball Reminders

Included within this memo are reminders regarding OSAA policies and NFHS rules specific to baseball that I would like you to review with your staff as we begin a new season. Remember that each school offering baseball should have received one copy of the NFHS Baseball Rules Book from the OSAA. If your school didn't receive your copy, please let me know. Feel free to contact me if you have questions.

- <u>OSAA Baseball Plan</u> The 2014 OSAA Baseball Plan is available on the OSAA website at <u>www.osaa.org/docs/bbl/bblplan.pdf</u>. This plan contains information regarding important season dates, state championships, NFHS rule changes and points of emphasis, OSAA baseball policies, participation limitations, etc.
- Interrupted Contests The OSAA Executive Board adopted a rule change last year to continue all regular season contests that are interrupted due to darkness and/or weather <u>from the point of interruption</u>. This rule is in effect again this season. See below for the procedure that umpires and teams shall follow in these situations:
 - a. The umpires, both head coaches and both scorekeepers shall gather together to document the point of interruption on the lineup card <u>and</u> in the official scorebook (including inning, score, outs, runners on base, defensive charged conferences, etc.). The crew chief shall sign the lineup card and the official scorebook to insure that there are two copies.
 - b. The crew chief should then give the signed lineup card to the home coach to be kept with the official scorebook.
 - c. The umpires shall send their game report to their local assigner. If a different umpire crew is assigned, the local assigner shall send the game report details to the new crew as part of accepting the assignment.
 - d. The lineup card shall be given to the new or returning umpire crew during the pre-game when the game is to be continued from the point of interruption.
- 3. Officials Host School Responsibilities The OSAA Executive Board recently changed the host school responsibilities regarding officials. Beginning this season, a game manager shall be designated by the host school for all contests. It's a good idea for the game manager to introduce themselves to the umpires upon arrival. A member of the coaching staff of the home team is not eligible to serve as game manager during a <u>varsity</u> contest at which he or she is coaching. <u>A</u> coach of a sub-varsity team may act as the game manager at a sub-varsity contest at which he or she is coaching. The game manager shall wear easily recognizable identification, <u>shall be physically present and/or readily accessible by phone</u>, and shall be responsible for:
 - a. Designating reserved parking for officials as close as possible to the contest site where available if requested by the commissioner of the Local Association providing the officials;
 - b. Designating dressing facilities for officials where available if requested by the commissioner of the Local Association providing the officials;
 - c. Monitoring and responding to inappropriate crowd conduct during and after the contest; and
 - d. Providing an escort to the designated dressing facilities or vehicle for officials following each contest unless that offer is declined.
- 4. Adding Games to Schedules After April 15 The OSAA Executive Board approved a change to the rankings policy for this year in an attempt to minimize the late season manipulation of the system. Consequently, results from contests added to a team's schedule after a certain date each season (Spring April 15) <u>vs. a team more than one classification</u> <u>away</u> shall not be included in the rankings.

- 5. <u>Jamborees</u> The OSAA Executive Board approved a rule change last year that allows schools to play three innings against another school in a jamboree. This rule is in effect again this season. Remember that the overall six inning limit and two inning limit for each pitcher are both still in effect.
- 6. <u>Game Balls</u> The question of what constitutes a game ball has come up several times the last few years as the price of baseballs has risen. Schools are reminded that per NFHS Baseball Rules, <u>the NFHS Authenticating Mark is required on all baseballs used for high school competition</u>. This includes all levels of play (Varsity, JV, JV2, Frosh). For the regular season, any brand of baseball is legal provided it has the NFHS Authenticating Mark. During the OSAA state playoffs, teams are required to use the Wilson A1010Pro. Also, remember that a minimum of three legal baseballs are required to start a game. Given our typical Spring weather, it's a good idea to have more than that available.
- Approved Bats for 2014 Season There are not changes in the bat rules from last year so for the 2014 season, all baseball bats must have the BBCOR Certification Mark or be made of a single piece of wood. No post-production, BBCOR label, sticker or decal will be accepted on any non-wood bat. The BBCOR Certification Mark will look something like this:

Please remember, umpires are no longer required to inspect bats and helmets. Instead, the umpire-in-chief shall receive <u>verbal verification</u> from both head coaches that all participants are properly uniformed and equipped with bats that are unaltered from the original manufacturer's design and production and helmets that meet NFHS and NOCSAE standards are free of cracks or damage.

- 8. Field Markings and Game Preparation A reminder to schools to have fields properly marked before a game begins. This includes all appropriate lines for batters boxes, coaches' boxes, the catcher's box, foul lines, runner's lane to 1st base, etc. It is recommended that all outfield fence signs are properly secured to the fence and off the ground. - Lightning Safety Guidelines The OSAA has made a concerted effort to educate member schools and officials associations regarding NFHS Lightning Safety Guidelines. Once thunder is heard or a cloud-to-ground lightning bolt is seen, all personnel, athletes and spectators should evacuate to available safe structures or shelters.

- 1) Assign a staff member to monitor local weather conditions before and during events.
- 2) Develop an evacuation plan, including identification of appropriate nearby shelters.
- 3) Develop criteria for suspension and resumption of play:
 - a) <u>Recognition</u>. When thunder is heard, or a cloud-to-ground lightning bolt is seen, the thunderstorm is close enough to strike your location with lightning. <u>Suspend play and take shelter immediately</u>.
 - b) <u>Thirty-minute Rule</u>. Once play has been suspended, wait at least thirty minutes after the last thunder is heard or flash of lightning is witnessed prior to resuming play.
 - c) Any subsequent lightning or thunder after the beginning of the 30-minute count should <u>reset the clock</u> and another thirty minute count should begin.
- 4) Hold periodic reviews for appropriate personnel.
- Ejections Multiple ejection reports came through the OSAA office last season where a player or coach had been ejected in the first game of a doubleheader. A reminder that when this happens, the player or coach is done for the rest of the day (Ejection Period) and is also suspended through the next contest at that level of competition (Suspension Period). Some schools have mistakenly thought that the 2nd game of the doubleheader counts as the suspension period.
 - a. Example #1 A <u>varsity</u> coach is ejected in the first game of a doubleheader. The coach is done for the rest of the day (**Ejection Period**). The coach is also suspended through the next <u>varsity</u> contest (**Suspension Period**).
 - Example #2 A JV player is ejected in a game on Friday (single game that day) and the JV team has a doubleheader the next day on Saturday. The player is done for the rest of the day on Friday (Ejection Period). The player sits out the 1st game of the Saturday doubleheader (Suspension Period) but is eligible to play in the 2nd game of the doubleheader on Saturday.





- 11. <u>Multiple Batters Warming Up During Dead Ball Time</u> We receive questions every year about multiple batters warming up during dead ball time. <u>The batter and one on-deck batter are the only players that should be in live ball territory warming up during infield warmups, the pre-game plate meeting, just prior to the first pitch of the game, in <u>between innings or during a stoppage of play</u>. This is first and foremost a safety issue as we've all seen incidents occur with overthrows, wild pitches, etc. Any other players wanting to warm up need to be in a dead ball area protected from live ball play (i.e. behind the dugout or batting cages, etc.).</u>
- 12. <u>Courtesy Runners</u> When a player enters as a courtesy runner, <u>it counts as an inning played for that individual</u>.
- 13. <u>OSAA Line-up Cards</u> The OSAA, in conjunction with the OAOA, created line-up cards a few years back. These line-up cards are recommended, but not required for use by the OSAA. - 14. Website Reminders and Tracking Out of State Opponents Varsity teams are required to update their schedule and results through the OSAA website throughout the season. Schools are also required to track records of out of state opponents. Each Oregon school is ultimately responsible for making sure their own schedule and results are accurate, including the records of their out of state opponents.
