SUBJECT: OSAA Officials Fee Review Committee – January 13 Web Conference

The Officials Fee Review Committee conducted an organizational meeting via web conference on January 13, 2015. The constitutionally mandated purpose of this Committee is to make recommendations to the OSAA Delegate Assembly for adoption in October 2015. These recommendations will consider only items involving fees paid to individual officials, commissioners, or Local Associations. This includes game fees, mileage, per diem, check writing fees, commissioner fees, or any other type of service fee provided.

The Committee reviewed the charge and will be provided a history of recent recommendations involving both regular season official's fees and supplemental fees charged to OSAA member schools. The Committee also discussed what types of materials they would like to be provided to them prior to their initial public meeting. The Committee agreed upon the following meeting schedule:

Tuesday, January 13, 2015 (initial meeting via web conference)  
Thursday, February 5, 2015 (public testimony)  
Thursday, February 19, 2015 (public testimony)  
Monday, March 16, 2015 (public testimony)  
Monday, April 6, 2015 (Closed Meeting – issue final recommendation)

The Committee requests that the focus of testimony for the Wednesday, Thursday, February 5, 2015 meeting be directed at the following topics:

- Development of a multi-year schedule for regular season officials, commissioner, and check writing fees – (current schedule expires after next year)

The OSAA staff will provide a Committee update, similar to this one, to all officials associations, superintendents, principals, and athletic directors following each meeting.
