SUBJECT: OSAA Football Ad Hoc Committee Update

The Football Ad Hoc Committee conducted its sixth meeting related to Football placements during the 2022 – 2026 time-block on April 14, 2022, via Zoom in a closed work session. Final Committee recommendations will be forwarded to the OSAA State Championship Committee for consideration and inclusion into their final recommendation that will be forwarded to the OSAA Executive Board for review and adoption at their May 2, 2022 meeting.

OSAA staff provided a summary of 4 pieces of correspondence received after the last meeting.

Final League/Special District Configurations by Classification

The Committee reached consensus on a final recommendation of all school placements and alignments for the 2022-2026 time block. Any requests by member schools to change classification or placement will need to be directed to the OSAA Executive Board for consideration at their May 2, 2022 meeting. (see attached)

Recommended Bracket Structure/Allocations

The table below summarizes the Committees final recommendations at all levels.

Classification	Bracket Type	Allocations
*6A	Top 16 + Next 16	PIL (4), Metro (3), Pacific (3), Mt. Hood (4) Three Rivers (3), Central/Southwest (5) + 10 via rankings

- * At the 6A classification the 32 qualifying teams would be divided into two brackets using final OSAA rankings.
 - Teams ranked #1-#16 and Teams ranked #17-#32 will be placed in separate brackets.
 - League champions ranked outside the top 16 will be moved into the 1-16 bracket and will bump the lowest seed possible to the 17-32 bracket.
 - Automatic qualifiers ranked outside of the top 32 will be moved into the 17-32 and will bump out the lowest possible seed.

6A Classification Bracket Structure/Allocations

The Committee spent considerable time discussing the caucus results and voting outcomes related to the formatting of the 6A Championships – specifically how those results impact the Committees current recommendation of an 8 team/24 team model. At issue is that 6A representatives attending the OSAA Delegate Assembly meeting and 6A Athletic Directors attending the OADA Conference, when combined, are nearly unanimous in support to modify the current model into two separate 16-team brackets.

There is sentiment amongst some Committee members that the two separate 16-team brackets do not solve the core issues the Committee was attempting to address although the model does take a step to address the lopsided matchups occurring in Round 1 by halving the seed differential (1-16 vs 1-32). The group recommends that both brackets are awarded trophies.

There continues to be consensus within the Committee that at a minimum it is necessary to change the current model in some way. While historical data review supports adopting an 8 team/24 team format and is the reason for the original recommendation the obvious lack of support requires consideration of other models. As such the Committee has reached consensus to support implementation of the two separate 16-team brackets at the 6A Classification level with all league champions included in the Top 16 bracket regardless of ranking.

2A, 1A Structure/Game Type

- Recommends that 2A schools (ADM 75 145) play the 9-player game.
- Recommends that 1A schools (ADM 74 61) play the 8-player game.
- Recommends that 1A schools (ADM 0 60) play the 6-player game.

6-Player State Championship

The group supports adoption of the 6-player game and is encouraging the OSAA State Championship Committee to recommend conducting an OSAA State Championship for 6-player teams.

Placement Criteria:

- Schools requesting a lower classification for the first time must have had a 2-year in-class winning percentage below 22%.
- Schools previously playing at a lower classification requesting to remain there must have had a 2-year in-class winning percentage of less than 67% and have not won an OSAA playoff game.
- Any school approved to remain down or has opted to play down that has an in-class winning percentage of 67% or higher and/or advances beyond Round 1 of any OSAA Football State Championship will automatically be moved back up for the following season.

The OSAA staff will provide a committee update, like this one, to all superintendents, principals, athletic directors, and football coaches following each meeting. The Committee roster, charge, and any additional committee information is available at http://www.osaa.org/governance/committees.

Proposal to Amend Board Policy – Football – Placement in a Lower Classification (Action Item)

QUESTION: Should the Executive Board amend Board Policy – Football – Placement in a Lower Classification to align with recommendations from the Football Ad Hoc Committee?

RATIONALE: The Football Ad Hoc Committee met over the past few months and adjusted their criteria for eligibility for placement in a different classification. The Delegate Assembly made modifications to Article 6.2.4.c. at its April meeting and these proposed changes align accordingly. The addition of an annual evaluation for teams placed in a lower classification factored prominently in their discussions.

FOOTBALL - PLACEMENT IN A LOWER DIFFERENT CLASSIFICATION

(February 2018)

- A. <u>Eligibility.</u> For a member school to be eligible for initial placement in a lower *different* classification as permitted in Article 6.2.4. (c), the school must meet at least one of the following criterions:
 - 1) Winning Percentage Four-Year. The school's in-classification winning percentage (Colley) in football for the previous four years shall be 22% or lower.
 - 1) Winning Percentage Two-Year. The school's in-classification winning percentage (Colley) in football for the previous two years shall be 22% or lower.
 - 3) Number of In-Classification Games. The school played twelve or fewer in-classification games in football during the previous four years.
 - 4) Enrollment Zone 11-Man vs. 8-Man. The school's adjusted base number enrollment is between 90 and 120, and the school intends to play 8-Man football.
 - 2) The school has petitioned to play above their assigned classification level.
- B. <u>Deadline.</u> A member school that meets one of the above criterions shall notify the OSAA of its intent to accept placement in a lower classification prior to January 15 of each even-numbered year beginning in 2018.
- C. <u>Duration of Placement.</u> Approval of placement in a lower different classification shall apply for two years, except as outlined below under Annual Evaluation.
- D. <u>Cooperative Sponsorship.</u> Schools involved in a cooperative sponsorship that participated together during the previous two-year or four-year period that also meet one of the above criteria are eligible for placement in a lower different classification. Newly formed cooperative sponsorships shall be subject to Executive Board Policy Cooperative Sponsorship.
- E. <u>Two-Year Evaluation.</u> Following two years of placement in a lower classification a school shall be evaluated to determine if the school should change classification again. The evaluation shall include, but is not limited to, the following criteria: in-classification winning percentage (Colley), league finish, playoff appearances/finish, program participation numbers, and adjusted base number enrollment.
- E. Annual Evaluation. Any school placed in a lower classification shall be evaluated annually to determine if the school should be returned to their originating classification. The evaluation shall include, but is not limited to, the following criteria:

- 1) Any school previously playing at a lower classification requesting to remain there must have had a 2-year inclass winning percentage of less than 67% and have not won an OSAA playoff game to remain at their current classification.
- 2) Any school approved to remain down or has opted to play down that has an in-class winning percentage of 67% or higher and/or advances beyond Round 1 of any OSAA Football State Championship will automatically be moved back to their originating classification.

Proposal to Amend Board Policy – Certification – Athletic Directors and Coaches (Action Item)

QUESTION: Should the Executive Board amend Board Policy – Certification – Athletic Directors and Coaches to align with recommendations from the Football Ad Hoc Committee and Oregon Athletic Coaches Association?

RATIONALE: As USA Football shifts their focus to youth football, the NFHS has created their own free football tackling course. This change, along with having an OSAA Master Trainer conduct the in-person Player Safety Coach clinics, aligns the two components moving forward.

CERTIFICATION – ATHLETIC DIRECTORS AND COACHES

Athletic directors and coaches shall achieve certification in the following areas prior to assuming duties as an athletic director or coach. The high school principal shall be held accountable for verifying that athletic directors and coaches have been certified. **EXCEPTION**: Any emergency exception to an OSAA requirement must be authorized in writing by the OSAA.

- A. <u>NFHS Fundamentals of Coaching</u>. The OSAA requires that athletic directors and coaches must achieve a passing score on the test included with the NFHS Fundamentals of Coaching course. This is a one-time requirement.
- B. <u>Concussion Recognition and Management Training</u>. The OSAA and Oregon State Law (<u>ORS 336.485</u>) requires that athletic directors and coaches receive training to learn how to recognize the symptoms of a concussion and how to seek proper medical treatment for a person suspected of having a concussion. The NFHS's Concussion in Sports free course satisfies this requirement. This training is required annually.
- C. <u>NFHS Heat Illness Prevention</u>. The OSAA requires that athletic directors and coaches must achieve a passing score on the test included with the NFHS's Heat Illness Prevention free course. This training is required once every four years.
- D. Anabolic Steroids and Performance-Enhancing Substances Training. The OSAA and Oregon State Law (ORS 342.726) require that athletic directors and coaches receive training on identifying the components of anabolic steroid abuse and use and prevention strategies for the use of performance-enhancing substances. This training is required once every four years.
- E. <u>Spirit Safety Clinic (Cheerleading and Dance/Drill Coaches Only)</u>. The OSAA requires that any cheerleading or dance/drill coach receive spirit safety training by achieving a passing score on the test included with the OSAA's online Spirit Safety Clinic. This training is required annually.
- F. NFHS Football Tackling Certification. The OSAA requires that any football coach complete the USA Football Heads
 Up Certification NFHS Football Tackling Certification prior to assuming coaching duties and to recertify annually prior to the beginning of each Association year. Additionally, each member school sponsoring football is required to identify a Player Safety Coach. Each Player Safety Coach is required to attend an in-person clinic biennially prior to the start of the Association year that is conducted by an USA Football Master Trainer OSAA Master Trainer in preparation for implementing and overseeing the primary components of Heads Up Football player safety program at their school.

SUBJECT: Update on the Proceedings of the State Championship Committee

The State Championship Committee for the 2022-26 four-year time block held its fifth and final public meeting at the Holiday Inn, Wilsonville on April 18, 2022, to receive testimony and review written correspondence received thus far.

After Committee introductions and an explanation of the meeting and testimony procedure, the Committee received testimony from six individuals online and 10 people in person with other individuals able to watch the meeting live stream via the OSAA's YouTube channel. The Committee then adjourned to a closed work session to review and discuss the testimony, written correspondence, and documents prepared by the OSAA staff prior to the meeting.

The following recommendation will be forwarded to the OSAA Executive Board for consideration at their May 2 meeting.

Cross Country State Championships: Location - Lane Community College (Eugene)

6A: 18 qualifying teams (Top 2 per league + 4 at-large qualifiers) plus top 14 individuals across the line.

5A: 13 qualifying teams (Top 2 per league + 5 at-large qualifiers) plus top 7 individuals across the line.

4A: 13 qualifying teams (Top 2 per league + 1 at-large qualifier) plus top 7 individuals across the line.

3A Boys: 12 qualifying teams (Top 2 per special district (4) + 4 at-large qualifiers) plus top 7 individuals across the line.

2A/1A Boys: 10 qualifying teams (Top 2 per special district (4) + 2 at-large qualifiers) plus top 7 individuals across the line.

3A/2A/1A Girls: 14 qualifying teams (Top 3 per special district (4) + 2 at-large qualifiers) plus top 7 individuals across the line.

Volleyball State Championships: Locations - 6A-5A (TBD), 4A-3A (TBD), 2A-1A Ridgeview (Redmond)

6A: 32 team bracket; three automatic qualifiers per league (21), plus 11 at large via the rankings.

5A: 16 team bracket; 5A-1 & 5A-3 receive four automatic qualifiers, 5A-2 & 5A-4 receive three automatic qualifiers (14), plus two at large via the rankings.

4A: 16 team bracket; eight automatic qualifiers (league champion plus top two #2 teams via rankings), plus eight additional qualifiers via play-in.

3A: 20 team bracket; four automatic qualifiers for 3A-5, three automatic qualifiers for all other leagues (19), plus one at large via the rankings.

2A: 16 team bracket; 2A-1 receive three automatic qualifiers, 2A-4 receives two automatics qualifiers, 2A-2 and 2A-3 receive four automatic qualifiers (13), plus three at large via rankings.

1A: 32 team bracket; four automatic qualifiers per league (32).

Soccer State Championships Locations - Hillsboro Stadium (6A-5A), TBD (4A, 3A/2A/1A)

6A: 32 team brackets; three automatic qualifiers per league (21), plus 11 at large via the rankings.

5A: 16 team brackets; 5A-1 & 5A-3 receive four automatic qualifiers, 5A-2 & 5A-4 receive three automatic qualifiers (14), plus two at large via the rankings.

4A: 16 team brackets; eight automatic qualifiers (league champion plus top two #2 teams via rankings), plus eight additional qualifiers via play-in.

3A/2A/1A: 20 team brackets. Allocations per league/rankings to be determined by the OSAA Executive Board in September.

Football State Championships: Locations - Continue with current practice of neutral sites for semifinals and finals.

6A: Two 16 team brackets. Teams ranked 1-16 in one bracket and 17-32 in a separate bracket.

5A: 16 team bracket; SD #1, #2 & #3 will receive four automatic qualifiers, SD #4 receives three (15) plus one at large via the rankings

4A: 16 team bracket; all leagues receive three automatic qualifiers (15) plus one at large via the rankings.

- **3A**: 16 team bracket; SD #1, #2 & #3 receive three automatic qualifiers, SD #4 receives four and SD #5 receives two (15) plus one at large via the rankings.
- 2A: 16 team bracket; all leagues receive three automatic qualifiers (15) plus one at large via the rankings.
- 1A-8: 12 team bracket; each special district receive four automatic qualifiers (8) plus four at large via the rankings.
- 1A-6: 8 team bracket, SD-1 receives three automatic qualifier and SD-2 receives five.

Cheerleading State Championships: Location – Oregon City High School

The Committee supports the addition of the Gameday division to the State Championships. Extending the maximum number of participants to 30 on the floor at all divisions. Each division (6A, 5A, 4A, 3A/2A/1A, Gameday, 6A/5A COED, 4A/3A/2A/1A COED), must have a minimum of five teams participating to be held. Schools may only participate in one division at the state championships. In the attempt to increase participation, the Committee recommends, along with the increase to a maximum of 30 participants from 20, to separate programs of 16 participants or more (6A, 5A, 4A, 3A/2A/1A) into their own division.

Swimming State Championships: Location - Tualatin Hills Park and Recreation (THPRD)

6A: First place winner in each individual and relay event at each District Meet automatically qualifies. Any remaining open lanes will be filled by the next fastest times from District Meet finals, up to a total of 18 participants.

5A: First place winner in each individual and relay event at each District Meet automatically qualifies. Any remaining open lanes will be filled by the next fastest time from District Meet Finals, up to a total of 12 participants.

4A/3A/2A/1A: First place winner in each individual and relay event at each District Meet automatically qualifies. Any remaining open lanes will be filled by the next fastest time from District Meet Finals, up to a total of 12 participants.

Wrestling State Championships: Locations – Veterans Memorial Coliseum (6A,5A); TBD - (4A, 3A, 2A/1A)

6A: 24-person bracket; three qualifiers per weight class per league. 4th place finisher from each league will be "pooled" and a defined criterion applied to select three additional qualifiers.

- **5A**: 16-person bracket; four automatic qualifiers per weight class per league.
- **4A**: 16-person bracket; four automatic qualifiers per weight class per special district.
- 3A: 12-person bracket; number of special districts and number of qualifiers per special district to be determined.
- 2A/1A: 10-person bracket; number of special districts and number of gualifiers per special district to be determined.

Girls: Two 8-person brackets (6A/5A; 4A/3A/2A/1A) that would be held at the same time and location as their related classification.

Basketball State Championships (Boys & Girls): Locations - University of Portland (6A), Oregon State University (5A), Forest Grove HS (4A), Marshfield/North Bend HS (3A), Pendleton Convention Center and High School (2A) and Baker High School (1A)

Eight teams to final sites. Keep current structure of four-day tournaments at 6A, 5A, 1A and three-day tournaments at 4A, 3A, 2A

- 6A: 32 team brackets; three automatic qualifiers per league (21), plus 11 at large via the rankings
- **5A**: 16 team brackets; 5A-1 & 5A-3 receive four automatic qualifiers, 5A-2 & 5A-4 receive three automatic qualifiers (14), plus two at large via the rankings
- **4A**: 16 team brackets; eight automatic qualifiers (league champion plus top two #2 teams via rankings), plus eight additional qualifiers via play-in
- **3A**: 20 team bracket; four automatic qualifiers for 3A-5, three automatic qualifiers for all other leagues (19), plus one at large via the rankings.
- **2A**: 16 team brackets; 2A-1 receive three automatic qualifiers, 2A-4 receives two automatics qualifiers, 2A-2 and 2A-3 receive four automatic qualifiers (13), plus three at large via rankings
- 1A: 32 team bracket; four automatic qualifiers per league (32).

Dance/Drill State Championships: Location - TBD

The Committee supports the move to a Category Style State Championship with six categories (Traditional, Show, Pom, Hip Hop, Kick, and Jazz). A minimum of five teams must participate in a category for it to be competed. Any further sub-division of a category will be by classification (6A, 5A, 4A/3A/2A/1A) with a minimum of five teams participating in a classification for it to be separated.

Every school gets the option to participate in one category and the ability to qualify into one other (maximum of two categories per school). The State Championship Committee requests the Executive Board to review allowing teams to qualify in a third category after a two-year cycle of the championship and logistics are determined.

<u>Speech State Championships</u>: Location - Western Oregon University (Monmouth) Continue with current qualification and structure.

Solo Music State Championships: Location - TBD

Continue with current qualification and structure.

Band State Championships: Location - Oregon State University

Continue with current qualification and structure.

Orchestra State Championships: Location - Oregon State University

Continue with current qualification and structure.

Choir State Championships: Location - Oregon State University

Continue with current qualification and structure.

Golf State Championships: Locations – Rotation of Quail Valley, Trysting Tree, Emerald Valley, Eagle Crest

6A Boys and Girls – Each league will determine one team that directly qualifies for the state championship (7), seven additional teams through regional qualification. Each league will determine two individuals who automatically qualify for the state championship (14), seven additional individuals through regional qualification.

5A Boys & Girls – Each league will determine one team that directly qualifies for the state championship (4), four additional teams through regional qualification. Each league will determine two individuals who automatically qualify for state (8), ten additional individuals through regional qualification.

4A Boys – 10 qualifying teams overall via the four special districts. Top 5 individuals from each special district must be in the top 5 overall to qualify for the State Championship. Special District team allocations to be determined by the OSAA Executive Board

4A/3A/2A/1A Girls - 8 qualifying teams overall via the four special districts. Top 5 individuals from each special district must be in the top 5 overall to qualify for the State Championship. Special District team allocations to be determined by the OSAA Executive Board.

3A/2A/1A Boys - 12 qualifying teams overall via the four special districts. Top 5 individuals from each special district must be in the top 5 overall to qualify for the State Championship. Special District team allocations to be determined by the OSAA Executive Board.

Due to the lack of participation data, the State Championship committee recommends allowing the Executive Board flexibility to modify the championships, qualifications, and structures after participation data is available from Spring 2022.

Tennis State Championships: Locations - Tualatin Hills Tennis Center, Portland Tennis Center, and Oregon State University

6A Boys & Girls – 28-person bracket. Each league receives four singles and doubles teams.

5A Boys & Girls – 16-person bracket. Each league receives four singles and doubles teams.

4A/3A/2A/1A Boys & Girls - 16-person bracket. Each special district receives four singles and doubles teams.

Due to the lack of participation data, the State Championship committee recommends allowing the Executive Board flexibility to modify the championships, qualifications, and structures after participation data is available from Spring 2022.

Track and Field State Championships: Location - University of Oregon

6A Boys & Girls – Top 2 per league + 2 wildcards + standards (16 minimum)

5A Boys & Girls – Top 2 per league + 5 wildcards + standards (15 minimum)

4A Boys & Girls – Top 2 per league + 1 wildcard + standards (13 minimum)

3A Boys & Girls - Top 2 per special district (5) + 3 wildcards + standards (13 minimum)

2A Boys & Girls – Top 2 per special district (5) + 2 wildcards + standards (12 minimum)

1A Boys & Girls – Top 2 per special district (4) + 3 wildcards + standards (11 minimum)

All allocations listed above are guaranteed (meeting an automatic qualifying standard does not replace wildcard allotments). Due to the lack of participation data, the State Championship committee recommends allowing the Executive Board flexibility to modify the championships, qualifications, and structures after participation data is available from Spring 2022.

<u>Baseball State Championships</u>: Locations - TBD. Committee recommends moving all championships to Saturday at two locations

6A: 32 team bracket; three automatic qualifiers per league (21), plus 11 at large via the rankings.

5A: 16 team bracket; 5A-1 & 5A-3 receive four automatic qualifiers, 5A-2 & 5A-4 receive three automatic qualifiers (14), plus two at large via the rankings.

4A: 16 team bracket; eight automatic qualifiers (league champion plus top two #2 teams via rankings), plus eight additional qualifiers via play-in.

3A: Minimum of 16 team brackets. Allocations per league to be determined by the OSAA Executive Board. The State Championship Committee requests that the Executive Board review team participation information and align qualifying percentages for 3A baseball with qualification percentages in 3A volleyball and 3A basketball. Executive Board to determine allocations in February once teams are known.

2A/1A: Executive Board to determine bracket size and allocations in February once teams are known.

Softball State Championships: Location - University of Oregon

6A: 32 team bracket; three automatic qualifiers per league (21), plus 11 at large via the rankings

5A: 16 team bracket; 5A-1 & 5A-3 receive four automatic qualifiers, 5A-2 & 5A-4 receive three automatic qualifiers (14), plus two at large via the rankings

4A: 16 team bracket; eight automatic qualifiers (league champion plus top two #2 teams via rankings), plus eight additional qualifiers via play-in

3A: Minimum of 16 team brackets. Allocations per league to be determined by the OSAA Executive Board. The State Championship Committee requests that the Executive Board review team participation information and align qualifying percentages for 3A softball with qualification percentages in 3A volleyball and 3A basketball. Executive Board to determine allocations in February once teams are known.

2A/1A: Executive Board to determine bracket size and allocations in February once teams are known.

Additional Items of Support / Recommendations:

Reimbursement Formula: After feedback from the Delegate Assembly and the OADA, the Committee fully supports the removal of mileage from the reimbursement formula for round trips of 200 miles or less.

<u>2022-23 State Championship Calendar</u>: Some of the supported changes will have effects on the previously adopted 2022-23 calendar. The OSAA staff will present the updated calendar to the OSAA Executive Board at their May 2 meeting.

The OSAA State Championship Committee also solidified three recommendations to the OSAA Executive Board for their review in hopes of improving the process in the future.

- In the activities (Speech, Solo Music, Band, Orchestra, Choir, Dance/Drill and Cheerleading), review creation of a threshold for the minimum number of teams required to conduct a separate championship/division. The committee recognizes the uniqueness in each activity and everyone's goal to increase participation. However, the committee feels there are inequities between championships where one activity can have the entire classification participating while another activity could have very few. Assessing data points of participation over the upcoming time block will be important to solidify a threshold of holding a championship in the future.
- In conjunction with the Budget Committee, the State Championship Committee would like a thorough review of the OSAA reimbursement formula for potential updates. The State Championships Committee's focus is on the review of the number of students reimbursed while the Budget Committee is interested in the application of mileage formulas across all activities.
- The State Championship Committee understands that each activity is unique and has its own nuances but would like
 the Executive Board to assist future committees by potentially setting qualification percentage goals for team and
 individual championships. Example: In team activities, should the goal of the Association be to qualify 33%-50% of
 teams? Individual activities may have different percentages but using historical participation data and qualification
 figures should help the committee review proposals across the board and how they align with Associations goals.

The release of the Committee's Final Recommendation is not the final step in the public process. Member schools and the public will also have the opportunity to respond to the Committee's Final Recommendation to the Executive Board in writing prior to and/or in person at the public meeting at which the Board will act on the Final Recommendation on May 2, 2022, at the Holiday Inn, Wilsonville. The Board will meet at 9am to consider member school written input and public testimony prior to acting on the Committee's Final Recommendation.

OSAA Budget Committee April 19, 2022

Following are the recommendations from the OSAA Budget Committee related to fiscal year 2022-23:

- 1. Recommend that the OSAA Staff remain diligent when reviewing venues and formats for State Championship activities with a priority on fiscal responsibility while endeavoring to continue providing high quality, memorable state championship experiences for students and communities.
- 2. Recommend expediting and accelerating the adopted membership dues and fees schedule to get to \$2,500 by 2028. This acceleration will help the Association stay ahead of rising inflation rates and help offset rapidly rising costs for operations and state championship venues.
- 3. Recommend that the mileage reimbursement rates be set at 90% of the IRS rate for Officials/Staff (\$.53/mile) and 70% of the IRS rate for Executive Board/Delegate Assembly/Committees (\$.41/mile).
- 4. Recommend that the OSAA continue to invest in website development.
- 5. Recommend that the OSAA continue to commit assets, including specific funding for resources and training, towards equity, inclusion, and diversity initiatives set forth by the OSAA Equity and Diversity Committee.
- 6. Recommend maintaining the Association's contingency fund at a minimum of 6% with a goal of increasing the fund to 8% moving forward.
- 7. Recommend continued consideration of additional programming and emerging activities that will meet the needs of the students and increase participation today and in the future.
- 8. Recommend reviewing salary schedules for employees in order to maintain and recruit quality personnel. Also, recommends hiring an additional staff member.
- 9. In collaboration with the State Championship Committee recommendations, recommend a thorough review of the current Playoff Reimbursement Form for updates and adjustments as needed.
- 10. Recommend a review of ticket prices and related fees, including potential alignment of digital and cash purchases, with a focus on keeping student costs low while maintaining a consistent stream of revenue to the Association.

SUBJECT: Update on the Proceedings of the Cooperative Sponsorship Task Force

The Cooperative Sponsorship Task Force held its final meeting via Zoom on April 14, 2022. The Task Force has used a virtual format for all meetings that allows both Task Force members and those seeking to provide input the option of participating via webinar.

The Task Force began the meeting by reviewing feedback that was shared in both the OSAA Delegate Assembly meeting and the Oregon Athletic Director Association Conference Classification breakouts. Overall, the membership was very supportive of the recommendation from the Cooperative Sponsorship Task Force. Some groups expressed a concern regarding a coop team becoming dominant while remaining above the classification cutoff but believed that the proposed annual review would address those situations.

After hearing feedback from the membership, the Task Force remains supportive of the current policy remaining in place for the schools who fit within the requirements outlined. The group is also recommending an exception for schools interested in hosting a Cooperative Sponsorship where their combined ADM would go beyond the assigned classification of the largest school involved, with an annual review. Members are focused on providing participation opportunities in these situations and are aware that schools may utilize this exception with an eye toward success instead which is why the annual review language is critical.

The Task Force discussed and is currently supportive of the following exception to the Cooperative Sponsorship beginning in the 2022-23 school year:

To be considered for an exception, the combined ADM of the schools involved may not exceed 10% above the classification cutoff of the largest school. Criteria to be considered in an annual review would include roster size, number of participants from each school, geographic location, number of classifications between participating schools, and the ability for the schools to host their own teams. Any cooperative sponsorships granted an exception by the Executive Board will be reviewed on an annual basis.

Final recommendations will be presented to the OSAA Executive Board **at their May 2 meeting**. The Task Force appreciates your support and encourages your participation in this process. Proposal to Amend Executive Board Policy – Cooperative Sponsorship (Action Item)

QUESTION: Should the Executive Board amend Board Policy – Cooperative Sponsorship to allow schools to request an exception, including a required annual review, when their combined ADM would place them at a higher classification?

RATIONALE: The OSAA Executive Board commissioned a task force to review cooperative sponsorships following the classification and districting process. The group looked for ways to adjust the policy to better provide participation opportunities for students whose schools don't have enough students to offer an activity while recognizing that competitive balance issues could be present. The 10% figure is intended to align with the annual ADM review done by the Executive Board.

18. COOPERATIVE SPONSORSHIP

In order for two or more schools to qualify for cooperative sponsorship as permitted in Article 6.5., they must meet the following requirements:

- A. <u>Who May Apply</u>? Only full member schools may apply for cooperative sponsorship, not families or individuals. Cooperating schools should be located in the same geographic area. Schools requesting cooperative sponsorship approval should make every effort to co-sponsor an activity with the nearest school that also has difficulty sponsoring the activity by itself. Cooperative sponsorship shall be considered only for 4A, 3A, 2A and 1A schools.
 - **EXCEPTION**: The Executive Board also may approve cooperative sponsorships involving 4A, 3A, 2A or 1A schools with a 6A or 5A school if the 4A, 3A, 2A or 1A schools are located in an isolated area, are unable to find a closer 4A, 3A, 2A or 1A school willing to enter into a cooperative sponsorship agreement, or if the two schools are physically housed in the same building where students take classes together.
- B. <u>Classification</u>. Classification placement for the requested activity will be determined by the total combined ADM in grades 9-12 of the schools involved *per Article 6.3*.
 - **EXCEPTION**: If the total combined ADM in grades 9 through 12 causes the cooperative team to qualify for a higher classification, the schools requesting permission for a cooperative team may petition the Executive Board for an exception to this provision. Factors that may be considered by the Executive Board when evaluating a petition for an exception may include, but are not limited to, number of participants from each school, how much the combined ADM exceeds the classification cutoff point, and geographic considerations. To be considered for an exception, the combined ADM of the schools involved may not exceed 10% above the classification cutoff of the largest school. Criteria to be considered in an annual review would include roster size, number of participants from each school, geographic location, number of classifications between participating schools, and the ability for the schools to host their own teams. Any cooperative sponsorships granted an exception by the Executive Board will be reviewed on an annual basis.

- C. <u>School Board Approval Requirement</u>. The Governing Boards of the schools involved in the cooperative sponsorship shall jointly apply for such sponsorship listing reasons for the request.
- D. <u>Regular or Special District Approval Requirement</u>. Cooperative sponsorship applicants shall obtain approval from the regular or special district in which the proposed cooperative team will participate and submit the approval form with the Cooperative Sponsorship Application. Regular and special districts are encouraged to consider the philosophy discussed at the end of this Executive Board Policy when reviewing requests for support of a cooperative sponsorship application.
- E. <u>Deadline for Application/Dissolution</u>. The deadline for application or for dissolution for a cooperative sponsorship shall be the first contest date of the season in which the cooperatively sponsored team is to compete.
- F. <u>Timeline for Approval</u>. The Executive Board will attempt to act on an application at its next regular meeting following receipt of the application. However, the Executive Director can make a decision, subject to approval by the Executive Board.
- G. <u>Duration of Approval</u>. Any approved cooperative sponsorship shall be limited in duration to the remainder of the time block per application. If an application for cooperative sponsorship is granted for multiple years and the cooperating schools choose not to cooperatively sponsor a team during any year of the agreement, it will be necessary for the schools to reapply for permission to cooperatively sponsor a team during the remaining term of the agreement using the most recent ADM figures available.

Cooperative Sponsorship Philosophy

The philosophy that will guide the OSAA Executive Board in reviewing and approving applications for cooperative sponsorship of activities is as follows:

- A. The Executive Board will attempt to increase the number of students who are participating in activities by making activities available for students that would not be available in their school because of a lack of numbers if joint sponsorship did not occur.
- B. The Executive Board would prefer to see projects that combine smaller schools for sponsorship of an activity rather than a small school program combining with a larger school when the smaller school cannot support the activity alone because of a lack of numbers.
- C. Improving the quality of a team (e.g., better won-lost record) will not be a valid criterion in deciding whether approval should be granted.
- D. Agreements are limited in duration to the remainder of the time block but may be terminated by the Executive Board under the following conditions:
 - 1) Closing of one of the schools.
 - 2) Valid complaints from surrounding schools concerning recruiting.
 - 3) Complaints from parents, Governing Boards, students in cooperating schools, etc.
 - 4) Other valid reasons as determined by the Executive Board.
