### **2023-24 Reimbursement Formula** **Adopted by the OSAA Executive Board (September 2023)**

The formula below will determine state championship reimbursement for member schools. The formula prioritizes roundtrip miles\* traveled ( $M$ ) but also factors in the number of participants ( $P$ ) and the number of days ( $D$ ) a school participates in a state championship. An expense metric ( $E$ ) is calculated for each school participating at a state championship that will determine the school's proportion of the overall total expense metrics for all schools for that season. Schools are then reimbursed seasonally (Fall, Winter, Spring) based on their portion of that season's budgeted reimbursement.

$$E = 2 \cdot P^{0.8125} \times (2 \cdot M)^{(0.75 + D/16)}$$

2023-24 Total Reimbursement Budget: \$825,000

Seasonal Breakdown: Fall: \$288,750 (35%) Winter: \$231,000 (28%) Spring: \$305,250 (37%)

Schools will be reimbursed based on the number of participants in a state championship. The number of student participants in team sports is outlined per OSAA policy as listed below.

#### **Individual Sports & Activities**

Reimbursement will be determined by the number of participants competing in a state championship. Those activities include Band, Cheerleading, Choir, Cross Country, Dance/Drill, Golf, Orchestra, Solo Music, Speech, Swimming, Tennis, Track & Field, and Wrestling. Schools do not receive reimbursement for non-participating alternates.

#### **School Personnel**

The number of student participants in a state championship will determine the number of school personnel (i.e., coaches, directors, drivers, chaperones, etc.) for which the school will receive reimbursement. The OSAA will reimburse an additional person for every five student participants, up to a maximum of five.

*1 – 5 student participants = +1 school personnel*

*6 – 10 student participants = +2 school personnel*

*11 – 15 student participants = +3 school personnel*

*16 – 20 student participants = +4 school personnel*

*21+ student participants = +5 school personnel*

#### **Examples:**

- A school qualifying seven student participants in track & field will receive reimbursement for a total of nine people (seven student participants plus two school personnel).
- A 4A school with a football team participating in the first round of the state championships will receive reimbursement for a total of 45 people (40 student participants plus five school personnel).

\*Note: Schools traveling less than 200 miles round trip for a state championship event will not receive reimbursement.

Note:

1. Reserved Seating
  - A. Only schools offering reserved seating for regular season games may sell reserved seats for playoff games. Schools cannot increase the price of reserved seats for the playoffs. Regardless of what the school charges, the OSAA must receive their ticket price of \$10 for first / second rounds through semifinals.
  - B. If schools have not had reserved seating during regular season play, they may not institute such a policy for playoffs.
2. Student is any child age 5 and up through a senior in high school.
3. There is no admission charged to spectators at the Tennis, Golf, Solo Music, or Speech State Championships.

## STANDING PRIORITIES REVIEW

**OPERATIONS** – Continue to work with and foster mutually beneficial relationships with member schools and affiliated organizations (OACA, OADA, OAOA, OATS, SMAC, ODE, COSA, OSBA, NFHS, OMEA, DDCA, OCCA, etc.). Prioritize investments in technology and professional education/development within our staff to keep Oregon at the forefront of state / national initiatives.

*One of the strengths of Oregon is the positive relationships between professional organizations. The OSAA continues to work closely with the aforementioned organizations to provide the best experience possible for students, coaches, officials, and fans. OSAA Staff attends meetings for each of these partner organizations throughout the year.*

*The OSAA's website remains the main informational source for high school activities across the state. Integrations, like the new Beyond the Scoreboard Course, allow schools to monitor coach certifications with the touch of a button.*

*OSAA staff members are highly engaged at the state/national level. All four Assistant Executive Directors currently serve on a national committee either through the NFHS or NIAAA. Additionally, Executive Staff members present regularly at the COSA Law Conference, OADA State Conference, NFHS Section and Summer Meetings, etc.).*

**COMMUNICATIONS** – Continue to find effective ways to communicate who we are, what we do and how we do it to our member schools, coaches, students, and lay citizens. As a governing body, it's important to continue to engage in conversation around the positive aspects of interscholastic activities. Develop policies and procedures to ensure high school activities are safe and welcoming for all.

*The OSAA's investment in an additional staff member to oversee the Association's digital and social communication has seen significant returns over the past 18 months. The engagement via social media has grown exponentially and has allowed the OSAA, and its member schools, to better promote the positive stories and recognize student accomplishments from all classifications throughout the year.*

*OSAA Staff prioritized messaging to member school superintendents, principals, athletic directors, and coaches in the preseason, midseason, and prior to the postseason regarding sportsmanship best practices and the STAR initiative.*

**FINANCIAL** – Continue to monitor postseason events and make modifications when necessary. Ensure the short-term and long-term financial stability of the Association by monitoring day-to-day operations.

*The OSAA continues to utilize high school venues for numerous state championships. This allows the OSAA to keep costs down and provide a revenue stream for member schools while continuing to provide exceptional state championship experiences.*

*From the recommendation of the OSAA Budget Committee, the OSAA Executive Board adopted a three-year schedule to increase dues and fees to member schools. This provides the Association with a source of reliable revenue to continue its work as expenses continue to increase in all sectors.*

**FOUNDATION** – Continue to positively impact as many lives as possible via the OSAA Foundation through its programming. With the mission of *Enhancing the Future of Oregon High School Activities*, the focus is always upon getting students active, keeping them safe, promoting the great things our schools and students are achieving, and providing worthwhile experiences that will last a lifetime.

*The OSAA Foundation's strong programming continued in 2022-23. Through the Student Assistance Program, Participation Grants, Track & Field/Cross County Fund, and the Equity and Diversity Grant, more than 150 schools and 1000 students have been directly impacted by the Foundation this past year.*

## **2022-23 PRIORITIES REVIEW**

Prioritize the Association's equity work as it relates to the S.T.A.R. initiative and providing a safe and welcoming environment at interscholastic events, along with efforts to educate the membership on Title IX. Promote education and training of school personnel, officials, and spectators regarding these efforts, with an emphasis on involving student voice through the Student Advisory Council. Continue to provide resources to schools to proactively enhance current programming for all students.

***17 schools have become S.T.A.R. schools this past year. This has opened the door to continued education about creating a welcoming and safe environment during interscholastic events. In addition, information was recently sent to the 13,000+ individuals who've taken the Interrupting and Preventing Discriminatory Acts training to further their knowledge of what's expected before, during, and after competitions. Information regarding specific scenarios that have taken place was also included in the continuing education PowerPoint. The Student Advisory Council is seeking new applicants as many members graduated this past year.***

Be the leading voice and advocate in Oregon for increasing the number of contest officials. Support officials' associations and member schools in developing recruiting/retention tools to increase the number of officials in the state. Finalize Officials Fee Review Committee with an emphasis on making officiating more attractive to current and potential officials. Promote via our own avenues (OSAAtoday, social media, OSAA Radio/NFHS Network, etc.) and develop opportunities with statewide media and partners to promote the benefits of officiating and the need for more officials to offer participation opportunities for students.

***Through the Officials Fee Review Committee, a new fee schedule was adopted by the Delegate Assembly that increased pay for contest officials at all levels, plus set officials mileage rates at 100% of the IRS rate. The Officials Recruitment and Retention Committee continues to meet and develop ideas/initiatives to attract new officials. The NFHS provided the Association numerous social media posts about becoming an official and public service announcements regarding the need for better fan behavior towards contest officials. OSAA and OAOA staff gave dozens of interviews throughout the year to TV and print media as part of these efforts.***

Work to explore and partner with groups looking to expand participation opportunities for student participants through emerging activities. Collaborate with affiliated organizations (OACA, OADA, etc.) to assess new interests statewide.

***The Delegate Assembly heard presentations from Ski Racing, Water Polo, and Boys Volleyball in 2022-23. Ski Racing was eventually denied but Boys Volleyball and Water Polo could potentially be the first emerging activities in the state. Conversations around esports and Girls Flag Football continue with a number of schools showing interest in expanding their activity offerings.***

Implement changes resulting from the Classification and Districting and State Championship Committees. Organize task forces for Reimbursement Review, Championship Thresholds, and Petition to Play Down as recommended by the State Championship Committee. Continue to seek partnerships with state championship facilities that provide memorable experiences for participating students and member schools.

***The Reimbursement Review Task Force completed their work and presented significant changes to how the OSAA reimburses schools for state championship participation. These changes, eventually adopted by the OSAA Executive Board, provide equitable distribution across all activities, a stronger baseline for the Association to budget, and a long overdue increase to host school event management expenses. The other two task forces are being formed and will begin their work in the 2023-24 school year.***

Utilize new staff members and a return to full use of the OSAA office to take a fresh perspective on policies, rules, and events. Welcome member schools and affiliated organizations back to the office through use of the Board and Conference Rooms for meetings, workshops, etc.

***Over the past two years the OSAA has welcomed several new faces to the staff. These additions have helped strengthen the relationship with member schools and push the Association to a new level of leadership across the state. The new hires have brought a perspective from another state and from in-state small schools to help diversify the makeup of the staff and better serve the membership. Member schools, leagues, and partner organizations continue to utilize the OSAA office for meetings throughout the year.***

## 2023-24 PRIORITIES

Partner with the Oregon Athletic Officials Association (OAOA) and Oregon Athletic Coaches Association (OACA) to actively recruit and retain contest officials and coaches throughout the state. Develop and implement strategies to promote the benefits of officiating and coaching in an effort to deepen the pool of available personnel.

Develop deeper relationships with the state's colleges and universities administrations in an ongoing effort to provide memorable state championship experiences for students. These mutually beneficial relationships help OSAA provide meaningful experiences at venues students may never compete at outside of a state championship experience.

Engage schools in completing the Petition to Play Down Task Force process. Have meaningful conversations around the petition to play down and what it means for the communities it affects, especially those who have been playing down previously. Begin a thorough review of state championships qualifying percentages across all sports/activities through the Championships Threshold Task Force with a goal of completing by the end of the 2024-25 school year.

Develop and implement a robust plan of action for emerging activities. Engage third-party organizations, or if needed, act as the third party in the development of strategic plans for bringing new activities to the Association. Activities like esports and girls flag football do not have a central organization leading the conversation like boys' volleyball.

Engage more schools to become S.T.A.R. schools. Through this program we can positively impact the environments connected to interscholastic activities. With the constant turnover in coaches and administrators, it's imperative to continually educate about expectations when hosting an interscholastic contest.











Create a plan to implement mandating use of the Manage Staff feature on the OSAA website. This will allow the OSAA and member schools to ensure that all coaches are fully certified prior to participation. This will help member schools track and monitor coach certifications, help mitigate liability for having uncertified coaches, and ensure that school personnel are trained appropriately to provide a safe, education-based approach to interscholastic activities.

Collaborate with the Sports Medicine Advisory Committee (SMAC) and Oregon Athletic Trainers Society, along with OACA and OADA, to promote awareness regarding Emergency Action Plans (EAP). Provide resources to member schools to assist them in being prepared to act appropriately and decisively when an event occurs.

### STATE CHAMPIONSHIPS – TEAM SIZE

(Revised Fall 2013)

- A. The following limitations shall apply to replacement players and maximum team sizes for team sport State Championship events, first round through championship final. **NOTE:** Only players in uniform are allowed to participate in pre-game warm-ups.
- B. **Penalties for excessive team size:** Suiting up, warming up, or playing too many players shall be considered a gross act of unsportsmanlike conduct and may be punishable by fines, forfeiture and/or other penalties as determined by the OSAA Executive Board.
  - 1) **Baseball.** Team: Replacement of players applies to each game. A player replaced on the roster may be reinstated to the roster in subsequent rounds. Maximum in uniform: 6A - 20; all other classifications – 18.
  - 2) **Basketball.** Team: Replacement of players applies to each game. A player replaced on the roster may be reinstated to the roster in subsequent games. Maximum in uniform: 6A – 14; all other classifications – 12.
  - 3) **Football.** Team: Replacement of players applies to each game. A player replaced on the roster may be reinstated to the roster in subsequent games. Maximum in uniform: 6A-60, 5A-50; 4A-40; 3A-33, 2A-33; 1A(8)-24; **1A(6)-18**
  - 4) **Soccer.** Team: Replacement of players applies to each game. A player replaced on the roster may be reinstated to the roster in subsequent games. Maximum in uniform: 6A – 22; all other classifications – 20.
  - 5) **Softball.** Team: Replacement of players applies to each game. A player replaced on the roster may be reinstated to the roster in subsequent games. Maximum in uniform: 6A – 20; all other classifications – 18.
  - 6) **Volleyball.** Team: Replacement of players applies to each match. A player replaced on the roster may be reinstated to the roster in subsequent matches. Maximum in uniform: 6A – 14; all other classifications – 12.

Proposal to Amend Board Policy –  
Football – Placement at a Different Classification  
(Action Item)

**QUESTION:** *Should the Executive Board require a school who is petitioning to play football at a lower classification to submit specific information to the Football Ad Hoc Committee when considering the school's request?*

**RATIONALE:** Having this information will help the Football Ad Hoc Committee make an informed decision as to whether to recommend approval or denial of a school's request to play at a lower classification.

**FOOTBALL – PLACEMENT IN A DIFFERENT CLASSIFICATION** (Revised May 2022)

**(Placement in a Different Classification – Football Only)**

- A. **Eligibility.** For a member school to be eligible for initial placement in a different classification as permitted in **Article 6.2.4. (c)**, the school must meet at least one of the following criteria:
- 1) **Winning Percentage – Two-Year.** The school's in-classification winning percentage (Colley) in football for the previous two years shall be 22% or lower.
  - 2) The school has petitioned to play above their assigned classification level.
- B. **Required Information.** *A member school who meets the criteria of winning percentage shall provide the Football Ad Hoc Committee with the following information:*
- 1) ***Participation numbers by grade level (9 – 12)***
  - 2) ***Win/loss records, including point differentials, for each level in the program***
  - 3) ***Listing of any forfeits for each level in the program.***
  - 4) ***Coaching staff continuity for each level in the program.***
  - 5) ***School Administration continuity.***
  - 6) ***Description of off-season programs (team camp, youth camp, 7 on 7/lineman challenge, summer weights).***
  - 7) ***Youth program participation numbers by grade level and coaching staff continuity for the past four years.***
  - 8) ***Description of school/community support and action steps taken, or planned, by the school to return the program to its original classification.***
- C. **Deadline.** A member school that meets one of the above criteria shall notify the OSAA of its intent to accept placement in a lower classification prior to January 15 of each even-numbered year beginning in 2018.
- D. **Duration of Placement.** Approval of placement in a different classification shall apply for two years, except as outlined below under Annual Evaluation.



- E. **Cooperative Sponsorships.** Schools involved in a cooperative sponsorship that participated together during the previous two years that also meet one of the above criteria are eligible for placement in a different classification. Newly formed cooperative sponsorships shall be subject to **Executive Board Policy – Cooperative Sponsorship.**
- F. **Annual Evaluation.** Any school placed in a lower classification shall be evaluated to determine if the school should be returned to their originating classification. The evaluation shall include, but is not limited to, the following criteria:
- 1) Any school previously playing a lower classification requesting to remain there must have had a two-year in-class winning percentage of less than 67% and have not won an OSAA playoff game to remain at their current classification.
  - 2) Any school approved to remain down or has opted to play down that has an in-class winning percentage of 67% or higher and/or advance beyond Round 1 of any OSAA Football State Championship will automatically be moved back to their originating classification.

## Proposal to Amend Article 9.6 – Activities Advisory Committee

(Action Item)

**QUESTION:** Should the Executive Board propose an amendment to Article 9.6. – Activities Advisory Committee to the Delegate Assembly that would modify its composition?

**RATIONALE:** In a review of OSAA policies, the composition of the Activities Advisory Committee is not reflective of who oversees the music groups (i.e., choir and band/orchestra). This change would better align the committee with the advisory groups that oversee these activities.

### Article 9 – Standing Committees

#### Activities Advisory Committee.

- 9.6.1. Charge.** The Committee shall serve as a conduit for open communication among representatives of the activities and the school representatives and staff of the OSAA. The Committee shall not be a policy making body but shall serve in an advisory capacity to the Executive Board, Delegate Assembly and staff of the OSAA. The Executive Board will not consider any recommendations from the Dance Drill Coaches Association (DDCA), Oregon Cheerleading Coaches Association (OCCA), Oregon High School Speech League Coaches Association (OHSSLCA), **Oregon American Choral Directors Association (OR ACDA), Oregon Band Directors Association (OBDA)**, and Oregon Music Educators Association (OMEA) without the support of the Committee.
- 9.6.2. Composition.** The Committee shall be composed of two representatives of each of the OSAA sponsored activities – cheer, dance, music, and speech. Committee members shall be current high school employees. The Activities Representative to the OSAA Executive Board shall be an ex-officio member of the Committee.
- 9.6.3. Term.** The term of office for a member of the Committee shall be three years. A member shall not serve more than two consecutive terms. A member who is elected to fill a vacancy shall be eligible for up to two full three-year terms starting with the first meeting after election.
- 9.6.4. Meetings.** The Committee shall adopt an annual schedule of meetings based upon the issues under consideration. The schedule shall include an appropriate number of meetings in which to conduct the business of the Committee.

## Proposal to Amend Rule 1.4 – Responsibility of the Member School and Principal

(Action Item)

**QUESTION:** Should the OSAA Executive Board propose a revision to Rule 1 to the Delegate Assembly that would include the new *Beyond the Scoreboard* course?

**RATIONALE:** The proposal would align the rule with the current Board Policy that includes the two courses that meet the Interscholastic Coaching Course requirement.

### Rule 1 - Responsibility of the Member School and Principal

**Athletic Director and Coach Certification.** The high school principal shall be held accountable for verifying that athletic directors and coaches of all sports sanctioned by OSAA, plus Cheerleading and Dance/Drill, have been certified in the following areas prior to assuming duties as an athletic director or coach. The Executive Board may adopt additional certification requirements for athletic directors and coaches. **EXCEPTION:** Any emergency exception must be authorized in writing by the OSAA. See *Executive Board Policies, "Certification – Athletic Directors and Coaches"* for additional certification requirements for football, cheerleading and dance/drill coaches.

- 1.4.1. ***Interscholastic Coaching Course.*** *The OSAA requires that athletic directors and coaches must either complete the OSAA Beyond the Scoreboard online course or achieve a passing score on the test included with the NFHS Fundamentals of Coaching course. This is a one-time requirement.*
- 1.4.2. **Concussion Recognition and Management Training.** <http://www.osaa.org/coaches/requirements> The OSAA and Oregon State Law ([ORS 336.485](#)) requires that athletic directors and coaches receive training to learn how to recognize the symptoms of a concussion and how to seek proper medical treatment for a person suspected of having a concussion. The NFHS's Concussion in Sports free course satisfies this requirement. This training is required annually.
- 1.4.3. **NFHS Heat Illness Prevention.** <http://www.osaa.org/coaches/requirements> The OSAA requires that athletic directors and coaches must achieve a passing score on the test included with the NFHS's Heat Illness Prevention free course. This training is required once every four years.
- 1.4.4. **Anabolic Steroids and Performance-Enhancing Substances Training.** <http://www.osaa.org/coaches/requirements> The OSAA and Oregon State Law ([ORS 342.726](#)) requires that athletic directors and coaches receive training on identifying the components of anabolic steroid abuse and use and prevention strategies for the use of performance-enhancing substances. This training is required once every four years.
