

**OREGON SCHOOL ACTIVITIES ASSOCIATION (“OSAA” or “Sponsor”)
“TOYOTA TUESDAY TRIVIA CONTEST”
OFFICIAL RULES**

Prize

- A. Entrants will have the opportunity to win the “Trivia Contest Prize Vehicle,” which is one (1) 2021 Toyota RAV4 XLE (approximate retail value US \$31,000). The depiction of the Trivia Contest Prize Vehicle in any advertising or promotional materials or physical display may not reflect the actual vehicle delivered to the Winner.
- B. No substitution or transfer of prizes or cash redemption is permitted. Portland Northwest Toyota Dealers Association (“TDA”) reserves the right to substitute a prize (or portion thereof) with a prize of comparable or greater value, in its sole discretion. Winner is responsible for the reporting and payment of all federal, state and local taxes (if any) and any other costs and expenses associated with prize acceptance and use not specified in these Official Rules and/or in the applicable entry instructions as being provided.
- C. The winner shall be required to execute an affidavit of eligibility and liability/publicity release provided by Sponsor (the “Affidavit”) and return the notarized Affidavit to Sponsor within fourteen (14) days to Sponsor, or an alternative winner shall be selected. The Winner shall provide any and all additional documentation that may be required by TDA for receipt of the Toyota Contest Prize Vehicle.
- D. TDA shall not be responsible for delays in delivery of the Trivia Contest Prize Vehicle, and delivery is subject to availability. TDA, however, shall use all reasonable efforts, subject to availability, to deliver the Toyota Contest Prize Vehicle within one hundred eighty (180) days after receipt of the Affidavit. The Winner shall bear all risk of loss or damage to the Toyota Contest Prize Vehicle after it has been delivered to the specified delivery site. The Winner must personally retrieve the Toyota Contest Prize Vehicle within thirty (30) days of written notification of delivery and must present adequate personal identification, evidence of legally required insurance and registration and complete an IRS Form W-9 (or Winner’s rights to the Toyota Contest Prize Vehicle shall be automatically forfeited).
- E. The Toyota Contest Prize Vehicle will be delivered solely with the express written limited warranties set forth in the Toyota Contest Prize Vehicle’s applicable Owner’s Guide, which warranties shall run for the term set forth in said Guide.

How to Play

The Toyota Tuesday Trivia Contest will begin December 22, 2020 and end June 15, 2021 (the “Contest Period”). OSAA will post a trivia question on the *OSAA Live* mobile app each Tuesday during the Contest Period and accept answers to the trivia question through the following Monday at 5:00 PM PST (each a “Contest Week”). Each correct answer will be one entry for a chance to win the Toyota Contest Prize Vehicle. Entrants may only participate in the Toyota Tuesday Trivia Contest via *OSAA Live* mobile app or by submitting a mail-in entry, as described below in the Eligibility and Participation section. Participation by either method of entry renders the participant an “entrant.” An entrant may only submit one answer to the trivia question by one entry method each Contest Week.

How to Win

- A. One entry (“Selected Participant”) submitted during the Contest Period will be randomly selected on June 16, 2021 (the “Final Drawing”) to participate in an on-field/on-court promotion for a chance to win the Toyota Contest Prize Vehicle. The on-field/on-court promotion will take place the week of June 21-27, 2021 (the “On-Field Promotion”) and is dependent on active OSAA-sanctioned activities with fans in attendance in accordance with government guidance. Selected Participant will be notified via email sent to the email account associated with entrant’s *OSAA Live* mobile app account (“Contest Notification”), will have twelve (12) hours to confirm participation in the on-field/on-court promotion, and must meet

all eligibility requirements.

- B. If there is a dispute as to the identity of a Selected Participant, the winning entry will be declared to have been made by the authorized email account holder at time of entry. Such Selected Participant will be disqualified, the prize will be forfeited and an alternate Selected Participant will be selected by alternate random drawing from among all remaining eligible entries at Sponsor's sole and absolute discretion if: (i) any Contest Notification is returned as undeliverable; (ii) a Selected Participant declines to participate in the On-Field Promotion; (iii) a Selected Participant fails to comply with any of the Official Rules; or (iv) a Selected Participant does not respond to the Contest Notification within twelve (12) hours of receipt of the Contest Notification.
- C. The Selected Participant becomes the Winner if they successfully complete the On-Field Promotion, per the rules outlined in the Contest Notification.
- D. The decisions of the Sponsor in all matters regarding the Toyota Tuesday Trivia Contest are final and binding.
- E. Odds of winning depend on the number of eligible entries received.

Eligibility and Participation

- A. **NO PURCHASE IS NECESSARY TO ENTER OR CLAIM PRIZE. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING.**
- B. "Toyota Tuesday Trivia Contest" is open to legal residents of Oregon, age twenty-one (21) years old by June 15, 2020 or older, and each entrant must be a U.S. licensed driver.
- C. Employees, their spouses and immediate families (parent, child, sibling, and any of their respective spouses) and household members (whether or not related) of OSAA, TDA, Playfly Sports, and FanThreeSixty, and each of their respective parent, subsidiaries, divisions, trustees, franchisees, participating vendors, distributors, affiliates, advertising and promotion agencies and affiliated entities, are not eligible to win.
- D. Prior to participating in the Toyota Tuesday Trivia Contest, entrants must download the *OSAA Live* mobile app and register with their full legal name and email address. Only the person identified by name as the Selected Participant on the Contest Notification at the time the Selected Participant's name is selected, which is supplied by the entrant during the *OSAA Live* mobile app registration, may claim the prize. Any change in name, whether due to marriage or otherwise, must be reflected on the entrant's account prior to participating in the Toyota Tuesday Trivia Contest in order to be eligible for any prize. Persons who register with fictitious names or emails will be ineligible to win any prize. In the event of sabotage, acts of God, terrorism or threats thereof, computer virus, health or other emergency, pandemic, epidemic, or communicable illness, including COVID-19, acts of federal, state, or local government, or other events or causes beyond the Sponsor's control, that corrupt the integrity, administration, security or proper operation of the Toyota Tuesday Trivia Contest, Sponsor reserves the right, in its sole discretion, to disqualify entrants and/or modify, cancel or suspend the Toyota Tuesday Trivia Contest. In the event of cancellation, Sponsor reserves the right to award the prize from among all eligible, non-suspect entries received prior to the event requiring such cancellation.
- E. To enter without using *OSAA Live* mobile app, print your full legal name, the Contest Week for which you are making a submission, your trivia answer, your email address and complete postal address on a 3" x 5" index card or piece of paper, write the words "TOYOTA TUESDAY TRIVIA CONTEST" at the top, and mail it to Toyota Tuesday Trivia Contest, Oregon School Activities Association, 25200 SW Parkway Avenue, Suite 1, Wilsonville, Oregon 97070 ("Mail-In Entries"). Mail-In Entries must be postmarked no earlier than the first day of the Contest Week for which it is being submitted and received no later than the last day of the Contest Week for which it is being submitted, and notwithstanding the foregoing, all Mail-In Entries must be received by June 14, 2021. Only one Mail-In Entry per envelope. Only one Mail-In Entry per person per Contest Week will be included in the Final Drawing. A Mail-In Entry with a correct trivia answer is considered an "entry" and the person submitting a Mail-In Entry is considered an "entrant".

- F. Receipt of entries will not be acknowledged or returned. Use of automated entry devices or programs is prohibited.
- G. - H. The Toyota Tuesday Trivia Contest is governed by U.S. law and is subject to all applicable federal, state, and local laws and regulations. By entering, entrants agree to accept and be bound by all terms of these official rules ("Official Rules"). Void where prohibited by law.

General

By participating in the Toyota Tuesday Trivia Contest:

- A. Entrant grants Sponsor and TDA and their designees the right and permission to use their name, address, photograph, testimonial or other likeness and/or prize information or personal exposition (and/or any edited portion thereof) for promotional, advertising and/or publicity purposes in any media, now or hereafter known throughout the world in perpetuity, without compensation or notice to, or further consent of, the entrant to the extent permitted by law.
- B. Entrant agrees to indemnify, defend, and hold harmless Sponsor and TDA, their respective employees, designees, officers, directors, shareholders, advertising agencies, and agents, from and against any and all claims, actions, demands and/or liabilities for injury/death, damage or loss to any person or property relating to or arising in connection with participation in the Toyota Tuesday Trivia Contest (regardless of the cause of such injury or loss), the delivery and/or subsequent use or misuse of the Toyota Contest Prize Vehicle awarded and/or printing, distribution or production errors. Winner acknowledges that the Vehicle Prize is awarded "as is" and that Sponsor and TDA have not made, and are not in any manner responsible or liable for any representation, guarantee or warranty, expressed or implied, in law or in fact, relative to any prize, including, but not limited to its quality, mechanical condition or fitness for a particular purpose. The Toyota Contest Prize Vehicle will be delivered solely with the express written limited warranties set forth in the Toyota Contest Prize Vehicle's applicable Owner's Guide, which warranties shall run for the term set forth in said Guide.

Disputes

- A. Except where prohibited, entrants agree that: (i) any and all disputes, claims and causes of action arising out of or connected with the Toyota Tuesday Trivia Contest or any prize awarded will be resolved individually, without resort to any form of class action and exclusively by the appropriate court located in Oregon; (ii) any and all claims, judgments, and awards to entrants will be limited to actual out of pocket costs incurred, including costs associated with participating in Toyota Tuesday Trivia Contest, but in no event attorneys' fees; and (iii) under no circumstances will entrant be permitted to obtain awards for, and entrant hereby waives all rights to claim, punitive, incidental and consequential damages, and any other damages other than for actual out of pocket expense and any and all rights to have damages multiplied or otherwise increased. All issues and questions concerning the construction, validity, interpretation and enforceability of these Official Rules or entrants' and/or Sponsor's rights and obligations in connection with the Toyota Tuesday Trivia Contest are governed by and construed in accordance with the laws of the State of Oregon, without giving effect to any choice of law or conflict of law rules.
- B. In the event of any conflict with any Toyota Tuesday Trivia Contest details contained in these Official Rules and Toyota Tuesday Trivia Contest details contained in promotion materials (including, but not limited to, point of sale, television, radio, and print advertising, promotional packaging, and other promotion media), the details of the promotion as set forth in these Official Rules shall prevail.
